PROJECT : 180 MW Kaligandaki Koban (KGK) Hydro Electric Project (Nepal)
LOCATION : VDC - Tukuche, Koban, Kunjo & Lete
District Mustang, Nepal

Ambeshwar Engineering Hydropower Pvt. Ltd. (AEHPL), a company registered according to Govt. of Nepal Act 2063, has decided to implement the 180 MW KGK Hydroelectric Project. The KGK Hydroelectric Project is located in Mustang District of Nepal. AEHPL invites sealed bids from eligible bidders for execution of the Project on Turnkey EPC basis

The scope of work under this includes but not limited to:

- Detailed Design, Engineering and Construction of all civil works at the Headworks, Dams, Head Race and Bypass Tunnels, Construction Adits, Pressure Shaft, Surge Tunnel and Valve Chamber, Pressure Shaft, Anchors, Access and Tail Race Tunnels in the Power Station. This includes procurement, transport, storage and installation of all material, equipment and tools necessary not only for construction but also for operation and maintenance as well.
- Design, Engineering, Procurement, Fabrication, Supply, Testing, Delivery, Storage and Erection of all hydraulic and hydro-mechanical steel structures (gates, valves, racks, liners, trifurcation pipes).
- Design, Engineering, Procurement, Fabrication, Supply, Transport, Storage, Testing and Construction and Installation of all Electromechanical, Electrical, Communication equipment required at the powerhouse and other structures. These include cable and telecommunication ducts, Control System, GIS Switchyard and Outgoing Gantry Structures, monitoring equipment, cooling system in the power station, ventilation system for Construction, Operation and maintenance of the plant
- Design, Engineering, construction and maintenance of all internal access roads

The Tender documents can be purchased on submission of a written application along with NRs. 20,000 or USD 250 only (In words: Twenty Thousand Nepali Rupees or Two hundred fifty United States Dollars only) either by cash, Demand Draft or Telegraphic Transfer to Nepal SBI Bank Limited Durbar Marg Kathmandu Nepal (A/c Number 17725240200335, Swift Code NSBINPKA) in favor of Ambeshwar Engineering Hydropower Pvt.
